Other Fees:

1. **Books ,Technology fees & Art supplies Fee:** **Preschool to 5th Grade : \$200 per student per year**
6th Grade to 8th Grade : \$250 per student per year
2. **Application Fee:** All **new students** will pay one-time non-refundable application fee of **\$100**
3. **Late Fee:** All returning students will pay a **late application fee of \$100 per student** if they do not re-enroll by **April 17th, 2026**
4. **Tuition-Deposit:** A **\$400 Tuition Deposit** must be submitted with the application for **each student**

Payment Plans (Please see the school office if you have any questions)

- Plan I: One Payment of entire fees by June 1st (\$150/student discount applies ONLY for Plan I)

Student report cards and academic records will not be released until payment is made in full. Students with delinquent accounts may not be eligible for readmission for the next academic year.

1. Parents will be liable for **25% of annual tuition fees** if student(s) withdraw **by September 30th, 2026**
 2. Parents will be liable for **50% of annual tuition fees** if student(s) withdraw **by December 1st, 2026**
 3. Parents will be liable for **100% of annual tuition fees** if student(s) withdraw **after December 1st, 2026**
- *The tuition deposit of \$400 per student is non-refundable in any of the above cases
